- Handling arraignments, including motions for reasonable bail or release without bail.
- Scheduling follow-up court appearances.
- Preparation of motions for factual and legal sufficiency.
- In felony cases, prepare for possible Grand Jury presentments, including witness preparation and client advice concerning assessment of case, evidence and exposure.
- Conducting trials in courts of law, where appropriate and necessary.
- Directing paralegals and other support staff for assistance in obtaining and reviewing discovery material, legal research and maintaining witness contact, as required.
- Negotiations with prosecutors for possible dispositions.
- Assisting attorneys of lesser experience in the performance of their professional obligations as set forth above.
